AN ORDINANCE PROVIDING FOR THE CHANGE OF THE
NAMES OF CERTAIN STREETS IN THE CITY OF PORTLAND.

The City of Portland does ordain as follows:

Changing street names.

SECTION 1. The names of the streets within the corporate limits of the City of Portland, be and the same are hereby changed as provided in section 2 of this ordinance, and the said streets shall hereafter be known by the names as provided in said section.

SEC. 2. That Fourth street, in what was formerly the City of East Portland, Kern's addition, Stephen's addition, Heiple's addition, Wheeler's addition and Holladay's addition to the said City of East Portland, and Margaretta avenue in what was formerly the town of Albina, Hogue and Catlin tract, Lincoln Park, Lincoln Park annex, Highland, Maegly Highland, Lesh's addition, Wait's Cloverdale annex, Roselawn and Killingsworth and Warren tract, and Piedmont Park; and Fourth avenue in what was formerly Albina homestead, and Fourth street in what was formerly Piedmont, Cloverdale tract, Cloverdale extension, Ainsworth tract, Green Ridge and Woodlawn Heights, be changed and hereafter known as Union avenue.

That "V" street, in Willamette Heights addition, Atkinson's addition, North Portland, Wilson's addition, Blackistone's addition and Watson's addition to the City of Portland, be changed and hereafter known as Vaughn street.

That Abernethy street, in what was formerly Elizabeth Irving's addition and Elizabeth Irving's Second addition to the City of East Portland, be changed and hereafter known as Vancouver avenue.

That Laurel street, in what was formerly Woodlawn in the City of Albina, be changed and hereafter known as Vulcan street.

That Thirteenth street, in what was formerly University Park and Norwood in the City of Albina, be changed and hereafter known as Vanderbilt street.

That Abernethy street, in what was formerly the Town of Albina and Vancouver road in what was formerly the Donner tract, Killingsworth tract and Killingsworth and Warren tract, be changed and hereafter known as Vancouver avenue.

That Sixth street, in what was formerly Arbor Lodge, and Sixth avenue in what was formerly Burrage tract, be changed and hereafter known as Villard avenue.

That Dartmouth street, in what was formerly Portsmouth Villa extended and Portsmouth Park in the City of Albina, be changed and hereafter known as Van Houten street.

That Sherman avenue, in what was formerly Arbor Lodge in the City of Albina, be changed and hereafter known as Vincent avenue.

That 3rd avenue, in what was formerly A. L. Miner's addition in the City of Albina, be changed and hereafter known as Van Bruen street.

That Davis street, in Blackistone's addition and Sherlock's addition to the City of Portland, be changed and hereafter known as Watson street.

That all that part of "B" street, in Couch's addition to the City of Portland, lying west of the north line of Washington street extended, be changed and hereafter known as Washington street.

That South Water street, in Caruther's addition to Caruther's addition and Caruther's addition as laid out by the

South Portland Real Estate Association, in the City of Portland, and Tenth avenue in Fulton Park to the City of Portland, be changed and hereafter known as Water street.

That Water street, in what was formerly the City of East Portland, and Ceder street in what was formerly Wheeler's addition and Holladay's addition to said City of East Portland, be changed and hereafter known as East Water street.

That Walnut street, in Fulton Park in the City of Portland, be changed and hereafter known as Wallace street.

That "W" street, in Willamette Heights addition, North Portland, Blackistone's addition, Sherlock's addition, Watson's addition to the City of Portland, be changed and hereafter known as Wilson street.

That Second street, in what was formerly Carter's addition to the City of East Portland, be changed and hereafter known as Weidler street.

That Sixth street, in what was formerly McMillen's addition and Elizabeth Irving's addition to the City of East Portland, be changed and hereafter known as Wheeler street.

That Johnson street, in Johnson's addition to the City of Portland, be changed and hereafter known as Wayne street.

That Mable street, in block "L" in Grover's addition to the City of Portland, be changed and hereafter known as Wall street.

That Hill street, in Willamette Heights addition to the City of Portland, be changed and hereafter known as Willow street.

That Second street, in what was formerly Farrell's addition and Farrell's Second addition to the City of Albina, be changed and hereafter known as Windsor street.

That "D" street, in what was formerly Riverside addition, and Alder street, in what was formerly Patton tract and Patton's second addition, all to the City of Albina, be changed and hereafter known as Webster street.

That Woodlawn avenue, in what was formerly Saratoga and Piedmont Park in the City of Albina, be changed and hereafter known as Woodlawn street.

That Second street, in what was formerly Peninsular addition No. 2, be changed and hereafter known as Waverly street.

That Second street, in what was formerly Portsmouth addition in the City of Albina, be changed and hereafter known as Warren street.

That Multnomah avenue, in what was formerly Maegly Highland and Maegly Highland addition, and "E" street, in what was formerly Piedmont, and Windsor street, in what was formerly Saratoga, all in the City of Albina, and Williams street, in Elizabeth Irving's addition and Elizabeth Irving's 2nd addition to the City of East Portland, be changed and hereafter known as Williams avenue.

That Tenth street, in what was formerly Willamette and Burrage tract, be changed and hereafter known as Wilbur street.

That Portland boulevard, in what was formerly Arbor Lodge in the City of Albina, be changed and hereafter known as Wabash avenue.

That "K" street, in what was formerly Peninsular addition No. 2 to the City of Albina, be changed and hereafter known as Washburne street.

That West "C" street, in what was formerly Peninsular addition No. 2 in the City of Albina, be changed and hereafter known as Winthrop street.

That all that portion of North Eighth street, in the City of Portland (the same being between Stark street and the south line of John H. Couch Donation land claim) be changed and hereafter known as West Park street.

That North Park and South Park street, in what was formerly Terminus addition and Riverside addition to the City of Albina, be changed and hereafter known as Willamette boulevard.

That "Y" street, in Sherlock's addition and Doscher's second addition to the City of Portland, be changed and hereafter known as York street.

That "P" street, in what was formerly the City of East Portland Park addition, Hawthorne Park, Central addition, Central Park addition annex to Central Park, Hanson's addition, Hanson's Second addition, Sunnyside and Sunnyside addition and Bartsch Park addition to said City of East Portland, be changed and hereafter known as East Yamhill street.

That Fifth street, in what was formerly Portsmouth and University Park in the City of Albina, be changed and hereafter known as Yale street.

That "L" street, in what was formerly the City of East Portland, Story's addition, Garrison's sub-division, Hanson's addition, Hanson's Second addition, Sunnyside, Crossier's addition, and Bartsch Park addition all in said City of East Portland, be changed and hereafter known as East Washington street.

That "E" street, in what was formerly McMillen's addition to the City of East Portland, be changed and hereafter known as Wasco street.

Not to affect proceedings pending for improvements, etc.

SEC. 3. Nothing contained in this ordinance shall in any way effect the validity of any proceedings now pending for

the improvement, opening, laying out, extending or widening of any of the streets above mentioned or for the changing or establishing of grades thereon, but such proceedings shall continue and be completed as though the names of such streets had not been changed.

AN ORDINANCE TO PROVIDE FOR THE PREVENTION OF INJURY TO PERSONS GETTING ON OR OFF CABLE CARS, ELECTRIC CARS AND MOTOR CARS.

The City of Portland does ordain as follows :

Street cars to be provided with gates--purpose and construction of.

SECTION 1. All closed cable cars, electric cars and motor cars run or operated upon any street in the City of Portland, containing double tracks for the use of said cars, shall be provided with gates for the platforms thereof, which gates shall be so constructed and used as to prevent passengers from getting on or off such cars between said double tracks, and all persons, firms or corporations owning or operating such cars on double tracks, as aforesaid, are hereby prohibited from permitting passengers to get on or off such cars between such double tracks.

Penalty.

SEC. 2. Any violation of the provisions of this ordinance shall be deemed a misdemeanor, and upon conviction before the Police Judge, the offender or offenders shall be punished
